4) FIRST AID MEASURES

4) FIRST AID MEASURES continued

Eye contact: Check and remove any contact lenses. Rinse eyes immediately with clean water for at least 15 minutes and seek medical aid.

Ingestion: Rinse mouth thoroughly with copious amounts of water. Give 1-3 cups of water or milk to drink. Do NOT induce vomiting. Keep patient at rest and seek medical advice. Loosen tight clothing. Do not give anything by mouth to an unconscious person.

First Aid facilities Ensure eye wash and safety shower are available.

Medical Attention: Medical conditions aggravated by exposure : asthma, skin and lung disease. Ingestion of large quantities may cause nausea and vomiting. Phosphates are laxatives.

5) FIRE FIGHTING MEASURES

Precautions for fighting fires Fire fighters should wear full protective gear, including self-contained breathing apparatus (AS/NZS 1715/1716). Keep unnecessary people away. If it can be done safely remove intact containers from the fire. Bund area with sand or earth to prevent contamination of drains or waterways. Dispose of extinguishing agent and spillage safely later. Do not release contaminated water into the environment.

6) ACCIDENTAL RELEASE MEASURES

Neutralise with weak acid. Neutralisation reaction may generate heat and fumes which can be controlled by rate of addition. Avoid contact with spilled material or contaminated surfaces. Do not smoke, eat or drink during the clean up process. Wear personal protective clothing and equipment as detailed in Section 8 PERSONAL PROTECTION. Keep people and animals away. Contain spill and absorb with earth, sand, clay or other absorbent material. Prevent spilled material from entering drains or watercourses. Collect and store in properly labelled drums for safe disposal. Clean floor with a damp cloth and place it in the drum. Seal drums and label ready for safe disposal. Deal with all spillages immediately. If contamination of drains, streams, watercourses etc is unavoidable warn the local water authority.

7) HANDLING AND STORAGE

Handling Keep out of reach of children. Will irritate eyes and skin. Avoid contact with eyes and skin. Do not inhale vapour or spray mist. After use and before eating, drinking or smoking wash hands, arms and face thoroughly with soap and water. After each day's use wash gloves and contaminated clothing.

Storage Store in the closed original container in a cool well ventilated area. Do not store for prolonged periods in direct sunlight. Store in a locked room away from children, animals, food, animal feed, seed and fertilisers. Protect from frost.

If no landfill is available bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots.
